

## EQUAL EMPLOYMENT OPPORTUNITY POLICY STATEMENT

It is SEFCU'S policy not to discriminate against any employee or applicant for employment because of their race, color, religion, sex, or national origin or because he or she is an individual with a disability or disabled veteran, Armed Forces service medal veteran, recently separated veteran, or active duty waliime or campaign badge veteran, or thereinafter referred collectively as "protected veterans" or any other characteristics protected under applicable law. It is also SEFCU's policy to take affirmative action to employ and to advance in employment, all persons regardless of their status as individuals with disabilities or protected veterans, and to base all employment decisions only on valid job requirements. This policy shall apply to all employment actions, including but not limited to recruitment, hiring, upgrading, promotion, transfer, demotion, layoff, recall, termination, rates of pay or other forms of compensation and selection for training, including apprenticeship, at all levels of employment.

Employees and applicants shall not be subjected to harassment, intimidation, threats, coercion or discrimination because they have engaged in or may engage in any of the following activities: (I) Filing a complaint; (2) Assisting or paliicipating in an investigation, compliance evaluation, hearing, or any other activity related to the administration of Section 503 of the Rehabilitation Act of 1973, as amended ("Section 503"), or any other Federal, State, or local law requiring equal opp01iunity for individuals with disabilities; (3) Opposing any act or practice made unlawful by Section 503 or its implementing regulations in this part or any other Federal, State, or local law requiring equal opp01iunity for disabled persons; or (4) Exercising any other right protected by Section 503 or its implementing regulations. Further, SEFCU will not discharge or in any other manner discriminate against employees or applicants because they have inquired about, discussed, or disclosed their own pay or the pay of another employee or applicant.

As President & CEO of SEFCU, I am committed to the principles of Affirmative Action and Equal Employment Oppoliunity. In order to ensure dissemination and implementation of equal employment opportunity and affirmative action throughout all levels of SEFCU, I have selected Barbara R. Hess as the Chief Administrative Officer for SEFCU. One of the Chief Administrative Officer's duties is to establish and maintain an internal audit and reporting system to allow for effective measurement of SEFCU 's programs.

In furtherance of this policy, SEFCU has developed a written Affirmative Action Program which sets folih the policies, practices, and procedures to ensure its policy of nondiscrimination and affirmative action for qualified individual s with disabilities and qualified protected veterans is accomplished. This Affirmative Action Program is available for inspection by any employee or applicant for employment upon request between normal business hours at the Human Resources depaliment.
